a. Annual Conflict of Interest Statement

Mr. Wilson distributed an annual Conflict of Interest Statement for the Board's review. He asked that if anyone had any questions about the statement to please reach out to him. He requested that each Trustee sign the statement and return it to Christine Lee.

b. Revisit President's 2022-2023 Annual Contract

Attorney Don Wilson reminded the Board members that their very positive annual evaluation of Dr. Falconetti that was unanimously approved during the May 23, 2022, Board meeting, automatically triggered the three-year renewal of the President's rolling employment contract for the period of July 1, 2022, and terminating June 30, 2025. During the June 27, 2022, DBOT meeting, the President's Contract of Employment for 2022-2023 was approved, however, it was agreed that the contract would be revisited during the August 22, 2022, DBOT meeting to take into consideration concerns that the absent Ms. Bell Barnett had with the existing level of compensation. Mr. Wilson emphasized that the contract can be amended at any time. He then requested Ms. Bell Barnett to address her concerns at today's meeting.

Ms. Bell Barnett highlighted the tremendous efforts and accomplishments achieved by Dr. Falconetti during the past year, including the \$53.1 million that the College received during the 2022 Legislative Session. In the contract approved during the June 27, 2022, DBOT meeting, Dr. Falconetti received the same 3% salary increase that was received by all faculty and staff of the College. Upon review of contracts and salaries of other Presidents at similar institutions within the Florida College System, Ms. Bell Barnett proposed that Dr. Falconetti receive an additional 5% salary increase.

Ms. Martinez moved, seconded by Ms. Ross, to approve and adopt the additional 5% in compensation in the President's 2022-2023 Annual Contract. All members voted affirmatively. Mr. Wilson noted that he would make the appropriate amendment to the President's 2022-2023 contract and emphasized that there are restrictions on making the additional 5% salary increase retroactive.
