## President's Report – Dr. Angela Garcia Falconetti

### a. Legislative Update

- Dr. Falconetti provided a brief summary of the College's legislative priorities.
- Meetings with members of the local delegation and Polk State Student Government Association (SGA) members took place during the February 9-10 Florida College System SGA Legislative event, which was held virtually.

## b. COVID-19 Response and Supplemental Relief

- The U.S. Department of Education (ED) recently announced the availability of an additional \$21.1 billion in higher education emergency relief funding for colleges and students.
- This funding, referred to as Higher Education Emergency Relief Fund (HEERF) II and authorized by the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA or Carissa), was signed into law on December 27, 2020.
- \$13.292 million has been allocated for Polk State; the ED requires that at least \$3.058 million of this allocation be used for student aid.
- Restrictions have not been communicated to date. The funding is non-recurring.

# c. Dr. Falconetti's Role as Chair of Policy and Advocacy Committee and Vice Chair of Florida College System Council of Presidents (COP)

- Meetings with various members of the Florida House and Senate are underway.
- February 19, 2021, Florida College System Council of Presidents meeting: Hosted Florida Department of Education Senior Chancellor Eric Hall, Florida College System Chancellor Kathy Hebda, and Florida College System Division of Career and Adult Education Chancellor Henry Mack.

The orange groves in the parcel to the west have recently been cleared for development.
