Dr. Angela M. Garcia Falconetti called the February 24, 2020, District Board of Trustees meeting to order at 4:00 p.m.

# President's Report

#### a. 2020 Legislative Update

- 1. Dr. Falconetti, Chair Martinez, Vice-Chair Ross, Director of the Student Activities and Leadership Office Melvin Thompson, and the presidents of the Student Government Associations (SGAs) for the Winter Haven and Lakeland campuses as well as the satellite centers visited Washington, D.C., from February 9 through February 12 to advocate for the College. They attended the Association of Community College Trustees National Legislative Summit and met with Senator Marco Rubio's legislative aide, Congressman Ross Spano, Congressman Darren Soto, U.S. Department of Education Assistant Secretary for Career, Technical, and Adult Education Scott Stump, and Deputy Assistant Secretary for Community Colleges in the Office of Career, Technical, and Adult Education Dr. Casey Sacks.
- 2. Dr. Falconetti attended the Association of Florida Colleges Council of Presidents meetings and a luncheon with Education Commissioner Richard Corcoran on February 19. Additionally, Chair Martinez, Vice-Chair Ross and Mr. Dorrell attended a reception hosted by Governor Ron DeSantis and the First Lady at the Governor's Mansion in Tallahassee.

# b. Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) Preparation

- 1. Dr. Mary Clark provided an update on the College's SACSCOC reaffirmation process. Dr. Clark shared that the College's Compliance Certification, which consists of 500+ pages and more than 1,600 supporting documents, has been compiled and verified. She noted that during the next two days, all the links will be tested. Once the testing has been completed, the Compliance Certification will be sent to the off-site review team no later than Thursday, February 27, so that it will be received by SACSCOC before the March 2 deadline. Dr. Clark expressed gratitude to SACSCOC Consultant Silver & Associates for its guidance.
- A separate piece to the reaffirmation process is the Quality Enhancement Plan (QEP), which continues to be developed and will also be reviewed by Silver & Associates. The submission deadline for the final QEP is in August 2020, six weeks in advance of the SACSCOC on-site visit October 26 through October 28, 2020.
