District Board of Trustees Meeting Monday, April 26, 2021 – 4:00 p.m.

Dr. Angela M. Garcia Falconetti called the April 26, 2021, District Board of Trustees meeting to order at 4:00 p.m. Three Board members attended the April 26 DBOT meeting in person; two attended via conference call; and one did not participate. Details referenced in attendance section below. Since four in-person Board members constitutes a quorum, a meeting quorum was not achieved. The April 26, 2021, DBOT meeting was only informational in nature, with no action items being presented. All action items were tabled until the May 24, 2021, DBOT meeting. Approval of Board Minutes

a. March 29, 2021, Board Minutes

President's Report - Dr. Angela Garcia Falconetti

a. President's Self-Evaluation to the Board: In anticipation of the Board's annual evaluation of the President each May, Dr. Falconetti provided a hard copy of her 2020-2021 Self-Evaluation to the Board for review and consideration. It was noted that hard copies of the self-evaluation would be delivered to the three Board members not in attendance today.

b. Legislative Update

- Dr. Falconetti shared that on Friday evening, the budget chairs, Senator Kelli Stargel and Representative Jay Trumbull, came to an agreement accepting the Senate's position on higher education funding. It was agreed upon to eliminate the language regarding cuts to operational funding for Florida colleges, including the proposed \$4.4 million cut to Polk State College. Dr. Falconetti expressed gratitude for the advocacy of the Polk State District Board of Trustees and the Polk County Legislative Delegation. She added that it is critical to emphasize that while this is positive news, the budget process is not over yet. The entire budget package will be sent to the Senate President and Speaker of the House for consideration and then must be approved by both the House and Senate prior to the close of session on April 30. The Governor's passing of the budget is the final step in the process. Dr. Falconetti has asked the Business Administration and Finance Office to begin to develop the College's budget based on the current positive outlook. A DBOT Budget Workshop is planned for 3:00 p.m., immediately prior to the 4:00 p.m. regular Board meeting on May 24, 2021. Additionally, the College is developing a spending plan for the COVID relief funds and will communicate the plan once finalized.
- Dr. Falconetti announced that Chair Ross will continue her current role as Chair of the Association of Florida Colleges (AFC) Trustees Commission in 2021-2022. In addition, Chair Ross led the 2021 Trustees Commission Virtual Legislative Conference on April 13 & 14, 2021. Dr. Falconetti represented the Florida College System Council of Presidents (COP) to present COP's 2021 Legislative Priorities & Substantive Bills.
