Dr. Angela M. Garcia Falconetti called the March 18, 2019, District Board of Trustees meeting to order at 4:00 p.m.

President's Report

- 1. Dr. Falconetti distributed copies of the March/April 2019 issue of "What's up?" which lists recent and current happenings at Polk State College. In particular, she referred the Board to the second bullet point, which announced Dr. Keith Bonney as Polk State Chain of Lakes Collegiate High School's new principal, following Ms. Bridget Fetter's retirement in February.
- 2. Dr. Falconetti introduced new VP of Institutional Effectiveness, Accreditation, and Research, Dr. Mary Clark, who joined the College on March 5.
- 3. Dr. Falconetti shared the recent editorial published by <u>The Ledger</u> on March 15, which highlighted the College's budget requests.
- 4. Dr. Falconetti thanked Chair Dan Dorrell, Vice Chair Teresa Martinez, and Board members Ashley Bell Barnett and Greg Littleton for accompanying her to Tallahassee to participate in Polk County Day on March 12 and to attend the Association of Florida Colleges Trustees Commission Legislative Conference March 13-14. While there, they met with several members of the Polk County Legislative Delegation to present the College's legislative priorities.
- 5. Dr. Falconetti stated that Florida TaxWatch, an independent, non-partisan, non-profit taxpayer research institute, announced at a press conference the results of their independent study of the economic impacts of the Florida College System (FCS). Their research revealed that the FCS provides a significant return on the state's investment. In particular, Polk State College boasts the second highest job-placement and continuing-education rate in the Florida College System at 96.9 percent.
- 6. Dr. Falconetti shared that she traveled to Tallahassee on March 7 with VP for Administration and CFO Peter Elliott and District Dean of Workforce Education & Economic Development, Dr. Orathai Northern, to present the College's Public Education Capital Outlay (PECO) Funding requests to the Higher Education Appropriations Subcommittee. She emphasized that it is very early in the Legislative Session, but that she would keep the Board informed relative to any developments regarding the College's PECO funding and budget requests.

Collegiate High School Report:

a. Polk State Lakeland Collegiate High School Application Status Report for Fall Term 2019 - Mr. Rick Jeffries

Mr. Jeffries provided a brief update on the Polk State Lakeland Collegiate High School (CHS) Application Status for the Fall Term 2019. He noted that CHS continues to have an overwhelming application response with the receipt of approximately 500 total applicants. Approximately 165 qualified applicants will be accepted bringing total projected enrollment, including returning students, to 325. CHS will continue to work from its waiting list throughout the summer as spots become available due to normal attrition. Final enrollment stats for the 2019 fall term will be calculated once the waiting list procedure ends at the end of the summer.
