# **District Board of Trustees Meeting** Monday, September 24, 2018 – 4:00 p.m. Winter Haven Campus, WST 126

Dr. Angela M. Garcia Falconetti called the September 24, 2018, District Board of Trustees meeting to order at 4:00 p.m.

### Foundation Special Recognitions: Ms. Tracy Porter

Dr. Falconetti recognized and thanked new Foundation Board Chair, Mr. Gary Boyer, for his service. She acknowledged Mr. Boyer's role in developing the "Falconetti Feather," a pin designed as a recognition opportunity for Polk State staff, volunteers, and donors who go "above and beyond." Dr. Falconetti presented each of the Trustees with a "Falconetti Feather" as a token of her appreciation for their service and support. Ms. Porter introduced Mr. Boyer to speak about today's special recognition. Mr. Boyer acknowledged a \$16,950 gift from ASAP Prints for scholarships and programs. He then recognized Nikki and Ed Smith, who briefly addressed the Board and expressed the critical importance of supporting education and making it affordable and accessible.

### Special Recognitions: Dr. Angela M. Garcia Falconetti

- a. Dr. Falconetti expressed gratitude to Chairman Dorrell and Mr. Littleton for their continued service to the College. On September 7, the Governor reappointed both Chairman Dorrell and Mr. Littleton to the Polk State District Board of Trustees.
- b. Chairman Dorrell congratulated Mr. Littleton on the recent community recognition he received. Mr. Littleton was honored as the Greater Winter Haven Chamber of Commerce Banker's Cup 2018 Man of the Year, which is considered Winter Haven's highest honor.

# **Approval of Board Minutes**

### a. August 27, 2018, Board Minutes

Ms. Ross moved, seconded by Ms. Barnett, to approve the August 27, 2018, Board minutes. All members voted affirmatively.

## **President's Report**

- **a.** Dr. Falconetti provided each of the Trustees with their own copy of the updated Florida College System Trustee Manual.
- **b.** Dr. Falconetti distributed copies of the August/September 2018 issue of "What's up?" which lists recent and current happenings at Polk State College.
- c. Fall Enrollment Report Enrollment for the fall semester reflected a 3.3% increase in full-time equivalent (FTE) enrollment. Unduplicated headcount reflected a 1.6% increase. Dr. Falconetti noted that fall enrollment data will not be final until December.
- d. Dr. Falconetti recognized Ms. Martinez and Consultant Dr. Martha Santiago for their roles in guiding the movement of the College to achieving Hispanic Serving Institution (HSI) designation. She emphasized that the College is currently considered an "emerging Hispanic Serving Institution," with a 22% Hispanic student population. To be categorized as an HSI, an institution must have a 25% Hispanic student population. Dr. Falconetti gave a special thanks to Ms. Martinez for ensuring ongoing Hispanic marketing exposure for the College in publications such as *El Trompetista* and on Hispanic radio. Dr. Falconetti shared that she, Ms. Martinez, and Dr. Santiago traveled to Washington, D.C., on September 7 and met with the co-founder of Excelencia in Education to most efficiently maximize the resources Excelencia offers. While in D.C., they also met with the president and CEO of the American Association of Community Colleges to further the College's mission.
- e. Dr. Falconetti distributed the Fall 2018 Arts Schedule and the 2019 Season Special Performance Series schedule for Board review. She encouraged Board members to attend any and all performances.
- f. Dr. Falconetti shared a couple of upcoming event reminders with the Board:
  - October 10: DBOT Retreat from 12:00 p.m. 3:00 p.m. in WMS 124 on the Winter Haven Campus.
  - October 12: College-wide Strategic Planning Summit from 8:30 a.m. 12:00 p.m. in LTB 1100 on the Lakeland Campus.

h. Hispanic Heritage Month – The College celebrated its kick-off for Hispanic Heritage Month on September 12 under the leadership of the Office of Equity and Diversity.

a. Polk State Chain of Lakes Collegiate High School – Ms. Bridget Fetter shared the 2018-2019 demographic data for Chain of Lakes Collegiate High School (COL) for the Board's information. She noted that the 314 enrollment data reflects the largest student body ever. Ms. Fetter shared that the school began a concerted effort three years ago to improve demographic diversity. Ms. Fetter congratulated COL faculty member Dr. Suzie Halverson on receiving a Polk Emerging Leaders Award, which recognizes young professionals across Polk County for making significant contributions and commitment to the community. She also noted that another COL staff member, Laura Abercrombie, was recently announced as the Kiwanis International Winter Haven student advisor of the year.
